3. What were common tasks under your position?

- President of Texas DECA
 - Read and write reports that illustrate the progress of Texas DECA
 - Listen to the ideas of others to put together the best possible solution
 - Smile: By smile, I mean make sure that you have a positive attitude as much as possible, especially in times of adversity and/or struggles.
- Texas DECA VP of Media
 - Create flyers, videos, and designs for all publications
 - Plan media calendars for the month
 - Promote a positive brand for Texas DECA
 - Advertise resources through social media
- District Officer connect with your district, successfully improve current problems within your district, and make sure that chapter members are heard

4. How many hours per week did you spend on average? How did this time commitment work out with other activities you are involved in?

• 5-6 hours per week for State Officers and 2-3 hours per week for District Officers

 Texas DECA Executive Director Mr. Shankle for advice. On occasion, I'll ask people from
